Treasurer

- Autumn sent me her report
- Report: Hey all! Autumn here, speaking through the medium of the incredibly attractive official standing before you today. Being your UniSFA treasurer for 2018 has been a huge privilege that, without exaggeration, changed my outlook on the world in ways I can't describe in a short report like this. As Treasurer I have enjoyed handling our finances, creating detailed spreadsheets and managing all expenditures and receipts. Through my own hubris and social anxiety, I also ended up doing almost every fridge run solo. Over the course of the year, thanks to generally very successful events, we have managed to significantly expand our savings.

You can get the detailed stats in the club's financial report which is hopefully being passed around right now, as well as the linked spreadsheet, but here are the key points:

We started the year with \$9,026 in our bank account.

At the time of the last general meeting, that had gone down to \$8,640.

Since then we have rocketed upwards for a final total of \$11,360.

This is largely thanks to the 40th anniversary party, which had a profit of \$1440.

We had several other profitable events, including Summer LARP and Cameron Halloween.

The fridge in the clubroom just about broke even over 2018.

In addition to treasuring, I served as organiser for quite a few events this year! I was a lead organiser for Camp, the 40th Anniversary Party, Quiz Night, and Winter LARP. I also put time into helping make sure Summer LARP and our two fundraising vigils happened. To anyone who attended even a single one of those events, I'm supremely grateful for having been able to share this experience with you.

Librarian

- Katherine sent me her report
- **Report**: With the addition of the compactus, we have 146m of shelf space total, and around 20% of that is obstructed. Around EIGHTY new items were bought, and around ninety removed. We lost our library storage due to our acquirement of space for the compactus.

I held an open meeting to discuss the library, where we agreed that we don't have the resources to function as an archive. Some alternative book storage and shelving arrangements were discussed and rejected. Graphic novel, DVD, and audio book loans were investigated.

I was able to make a significant repairing effort into the long backlog of damaged books. I made a small web-media recommendations section on the new website that Nike made, that I hope we can expand to podcasts, and an art gallery. Some tags and cw forms have been made for next committee to install.

I was involved with some really cool events this year: the book buys, the SwanCon stall, 40th anniversary party, the admin behind book clubs (shout out to Leah), two writing competitions with Creative Writing and Poetry (CWAP), ran a couple of fun UniSFA goes to the cinema events, and some screenings too! I was also involved with the new logo design process.

I strongly recommend that the committee proceed with weeding the library, in order to relieve the squeeze on the shelves, to allow access to all our library's items, and other benefits of weeding. The committee should also build some weeding regulations based upon the outcomes of the library discussion meeting, and continuous member feedback. The library is in want of a new Koha expert.

Oh, and the club won the Guild award, 'Most Inclusive Events' for our Book Clubs!

Fresher Rep

- Will sent me his report
- Report: Hi I'm will the current frep. I started half way through 2018 after Jaye stepped down from the position. It's been an interesting year. I started with helping organise and run the charity vigil and the Halloween party. Constitutional Amendments

15.1.2.1.

- The term 'maintain' where used throughout this constitution shall include the
 option of disposing of 'doubles' and other undesirable Library items by an
 appropriate method selected by the committee on a case by case basis.
 100% of any monies raised shall be earmarked for improving the library and
 attendant materials.
- Proposed: The term 'maintain' where used throughout this constitution shall
 include disposing of doubles; weeding undesired or excessively superfluous
 items to preserve space, according to committee's weeding regulations;
 promoting access to the library visually, physically, and electronically; and
 improving library operation and management systems.
- The change is designed to reflect the fact that our current library state and the fact that we can weed the library as a whole. There is some controversy as to whether this is a helpful framework.
- Annique thinks it's an alteration that doesn't add a great deal except for things that are conditional anyway
- People argue that this change is superfluous
- Is this meant to be in the constitution? Or should it be more of a handover thing?
- Katherine wants weeding to be defined in the constitution it is a common phrase in library management
- Maintenance of the library is already an objective of the committee
- Motion to change 15.1.2. to say 'improve' instead of 'expand' which should include the physical, aesthetic and electronic access to the library
 - o It is friendly so we don't have to vote on it
- Nike retracts proposed amendment
- Motion to vote on 16.3.6, at the same time as 15.1.2.1, as a bloc
 - This is withdrawn

- Amend amendment to only include the second half of Katherine's proposed additions, everything being removed isn't, 100% of monies are being moved 16.3.7
- Kurt would like to vote on them separately

- The term 'double' in this context refers to library items of which UniSFA
 possesses two or more copies. The decision of which copy (or copies) will be
 disposed of is to be made by the librarian in discussion with Committee,
 having regard to the value, condition, or other significance of the items, the
 most desirable to be retained for the UniSFA library
- Proposed: The term 'double' in this context refers to library items of which UniSFA possesses two or more copies, and donations to the library which have been rejected by the Librarian. Where applicable and reasonably practical, they will be offered to the donor. Else, they may be disposed of as per 16.2.
- Effectively makes it harder to remove doubles
- Donations don't count as library items until we've formally accepted them
- If people leave things in the room, that doesn't make them donations
- You can already get rid of doubles via 16.2
- Amendment fails
